The paper should be submitted through the EDAS paper submission system: https://edas.info/newPaper.php?c=32823. The length of the papers should not exceed 6 pages + 4 pages for over length charges.

Accepted and presented papers will be included into the IEEE Conference Proceedings published by IEEE CPS and submitted to IEEE Xplore. Authors of accepted papers, or at least one of them, are requested to register and present their work at the conference, otherwise their papers will be removed from the digital libraries of IEEE after the conference.
